The Committee and agency staff also discussed the status of the workforce for NEHRP agencies. The agencies will continue work to support their NEHRP mission.

#### V. 2025 ACEHR Report Discussion

Dr. Arendt led a discussion on the draft 2025 ACEHR biennial report. The Committee discussed suitable ways to address within their report:

- the development of the NEHRP Management Plan that supports the latest strategic plan's goals, objectives, and focus areas and their conversion to operational actions;
- · challenges in agency staffing; and
- inadequate resource support experienced across the agencies.

Other topics included incorporating the Government Accountability Office recommendations concerning performance metrics and strategic alignment of resources into the report. Dr. Arendt suggested the Committee review the agency updates, which recommendations should be prioritized and how to incorporate them into the biennial report.

The DFO reported that Mr. Randy Showstack registered to attend the meeting as a member of the public, but did not join the web conference nor did he provide any written communication for the Committee to consider.

Dr. Harris moderated a moment for the Committee to provide their appreciation to former NIST employee, Ms. Tina Faecke, for her hard work and dedication to the Committee since its official inception in 2006.
